Associates' Frequently Asked Dental & Vision Questions



1) Who is eligible to be an Associate Member and how much are the annual dues?

Associate members can be contractors, former PG&E employees, parents and adult children of active members. Adult children must be 21 years of age or older. The annual dues are \$45.00.

2) What's the difference between the dental plans?

There are three plans; Delta PPO, Delta Premier B, and Delta Care USA (PMI). You can find a plan comparison on our website www.PSEA.info. If you need additional information, please call Nour at 800-272-7732 ext 6212.

3) What are the quarterly premiums for Dental?

5) How do I know which plan my dentist accepts?

Delta Dental's website offers a great way to see which plan your dentist will accept. The website is www.deltadentalins.com. If you don't have internet access, you can call 800-765-6003 for a dentist in your area that accepts Delta PPO and Premier, or 800-422-4234 if you're searching for a Delta Care facility. You can also just ask your dentist which plan they fall under.

6) What's the difference between Plan B and Plan C for the Vision Service Plan?

The difference is Plan C gives you two additional glass lenses, blended and progressive. Also, rather than receiving frames every 24 months with Plan B you can receive them every 12 months with Plan C.

7) Is there a deductible or co-payment for the Vision plan?

8) What are the quarterly Vision premiums?

9) How do I find a VSP doctor in my area?

If you have internet access you can go to the VSP website www.vsp.com and click on Prospective Members. Then click on "find a VSP doctor" and then type in your address and the characters in the picture. Finally, click search. Otherwise, you can call 800-877-7195 to speak to a representative to find an eye doctor.

10) Are the premiums paid monthly?

No, they are quarterly payments, so they are due every three months. An invoice will be mailed a month prior to the due date for your convenience.

11) Do I have to send a payment with my application?

Yes, in order for us to process your application we do need your first quarterly payment.

12) When does my coverage begin?

You have to apply during the open enrollment and your coverage will begin the following month after the close of open enrollment.

13) What happens after I send in all my applications and payments?

Once we've processed your application you will receive a confirmation letter showing when your coverage will start and a payment schedule.
